DPW Spt. Donahue and Trustee LaPierre shared that they reviewed the applications and conducted interviews of certain individuals and shared their hiring recommendations. Spt. Donahue thanked the Board for their willingness to call for a special meeting as he wants to get the summer laborers started sooner rather than later.

→ Trustee LaPierre moved, Trustee Kristansen seconded, carried 3/0 to accept the recommendation of DPW Spt. Donahue and Trustee LaPierre to hire Alec Andrews and Jacob Bonisteel and Tyler Swan as DPW Seasonal (Summer) Laborers at a rate of \$12.40/hour, no benefits – authorized to begin work as soon as possible – pending successful completion of required pre-employment drug and alcohol testing.

Trustee Andrews said normally he would abstain as Alec Andrews is his grandson, however, a quorum is needed to approve the hiring and he has never opposed a hiring recommendation of Spt. Donahue so, this is consistent with his past practice.
