# MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING, is made this 25<sup>th</sup> day of June, 2013 by and between THE VILLAGE OF BROCKPORT, a New York municipal corporation having its principal offices in Brockport, New York (hereinafter referred to as the "Village"), and STATE UNIVERSITY OF NEW YORK COLLEGE AT BROCKPORT, a New York Educational corporation having its principal office at 350 New Campus Drive, Brockport, New York 14420 (hereinafter referred to as "College"). Said Village and College are hereinafter collectively referred to as the "Parties"

WHEREAS, Village is the owner of certain premises commonly known as Kenyon Street located in the Village of Brockport, County of Monroe, State of New York (hereinafter referred to as "Kenyon Street") and identified on the map attached hereto as Exhibit B, and

WHEREAS, College is the State University of New York College at Brockport and Kenyon Street separates the eastern portion of its campus from the larger western portion of the campus; and

WHEREAS, the Village's premises run through those held and owned by the College; and

WHEREAS, on February 29, 2012 the Village granted a Temporary Easement Agreement to the College giving the College access to carry out certain work on Kenyon Street, and the Parties have subsequently agreed that it is in the interests of the educational mission of the State University of New York that the street bed of Kenyon Street be included within, and as part of, the campus of the College at Brockport; and

WHEREAS, the parties have executed an Agreement transferring to the College title to the street bed of Kenyon Street, and

WHEREAS, the Village of Brockport was receiving certain funding and financial support from the State of New York in connection with the Village's possession, ownership, and maintenance of various streets and roadways within the Village and such support will now be decreased by the removal of Kenyon Street from the real property inventory of the Village, and

WHEREAS, the College wishes to provide certain funding to the Village on an annual basis to address the decrease in the aforementioned State funding as well as to support the Village in connection with its other obligations to repair and maintain the streets and roadways within the Village.

NOW, THEREFORE, in consideration of the mutual covenants contained herein,

# IT IS HEREBY AGREED AS FOLLOWS:

- 1. That within sixty (60) days following the transfer to the College of title to the street bed of Kenyon Street, the College shall make a payment to the Village of Brockport in the amount of \$1,500.00 (one thousand five hundred dollars) and shall thereafter make an annual payment in that amount on the anniversary date of the title transfer to the College.
- 2. Notwithstanding anything to the contrary in this agreement, the parties agree that this

memorandum of understanding shall be subject to the agreements, terms and conditions set forth in Exhibit A hereof to the same extent as if such agreements, terms, and conditions were set forth in full herein. In the event that any terms or conditions of this agreement shall be inconsistent with any agreements, terms, or conditions set forth in Exhibit A, then the

• Grants – Trustee Andrews shared that he is working with O'Connell Associates to prepare to apply for a Main Street grant regarding part of the Historic Commercial District. He has been soliciting interest from the applicable property owners and response has been very favorable thus far. The maximum grant is \$200,000 which provides up to 75% subsidies to the property owners.

Trustee Blackman shared that as Mayor, she will be appointing John D. La Pierre of College Street to her Trustee seat to 6/30/13. She said she believes he will be a great asset. He is a retired from Wegmans administration and brings financial, purchasing, management skills.

Trustee Blackman shared that as Mayor, she will be appointing Trustee Andrews as Deputy Mayor.

Trustee Blackman said she looks forward to continuing to work with Trustee Hannan and welcomes Trustee-Elect Ciciotti.

- Canal Trustee Blackman shared that the NYS Canal Corp's tug "Urger" will be traversing the canal this weekend with a crew and free public tours this Friday and Saturday from 10am to 4pm.
- Grants Trustee Blackman referred to the grant Trustee Andrews shared, that it is a TEP grant that could improve paths, trails, landscaping and lighting (a couple of new light poles) on the north side of the Canal. There would be a 20% match.

Trustee Blackman shared that she met with some SUNY and BCSD and Regatta folks regarding the possibility of bringing rowing here via a college club sport and high school club sport. It would require building a boathouse and floating dock at SUNY Commissary Park. They hope to apply for a \$150,000 Canalway grant.

Seymour Library - Trustee Blackman shared that she attended a meeting at the Library last Saturday as part of a focus group comprised of various stakeholders reviewing the Library, Board, staff, patrons, programs and such. They are working towards a re-branding and improving outreach to seniors. A survey is soon to come. There is still talk about the possibility of forming a Library District.

Clerk Morelli shared that Library Director Andrea Tillinghast has provided a copy of the most recent Library report and has asked to be scheduled on the 8/5/13 Village Board meeting as a Guest.

## o Trustee Kent R. Blair

Village Board - Trustee Blair thanked many people for their service and support during his term as Trustee. He found 4 years a long time to serve in local government during difficult conditions. He commended Mayor Castañeda for serving 8 years – 4 as Trustee and 4 as Mayor. Former Trustee Hal Legg helped convince him to run and said it would be a piece of cake. He learned the saying can be true that there are 2 speeds in government – slow and stop. He regrets some things just couldn't get done. He gained friends and some he thought were friends. He wavered on whether

seek re-election. It can be tough when you work full time, have a family, and other commitments. He said most of the incoming Village Board are retired or semi-retired. He believes the community will be
